



## **U.K Visa Requirements for Tourism/Visitor**

### **A. General Requirements**

1. Visa application form duly completed and signed.
2. Current passport with validity of at least 6 months after the end of the planned travel and must have two empty pages submit together with the Old Passports.
3. Photocopy of Bio Page of current passport.
4. Photocopies of all visas and immigration stamps for the last 5-10 years.
5. Two (2) passport sized photo with white background and not older 6 months.
6. Non-refundable visa application fee to be paid upon submission of visa application.
7. Proof of ties in the Philippines.
  1. Proof of social security contributions (if relevant)
  2. Proof of family ties in the Philippines (**e.g., Original and Photocopy of birth certificate of applicant and marriage certificate**). These certificates should be issued by the Philippine Statistic Authority (PSA).
  3. If widowed, original and photocopy of death certificate of spouse
  4. Copy of real estate property – title –deed, if relevant

### **B. Supportive Documents**

#### **Proof of financial means of the applicant**

1. Bank certification, Bank books (**should be authenticated by the issuing bank**), personal bank statements showing regular income (**6 months**), credit card statements or balance covering the last six months
2. Certificate of leave of absence (for Government Employees only)
3. Latest Income Tax Return (1701, 2316)
4. Photocopy of company ID
5. Photocopy of IBP or PRC license for professionals



#### If Self-employed

1. Photocopy of proof of company registration issued by the Department of Trade of Industry (DTI)/Securities Exchange Commission SEC registration of business (proof of registration and commercial activity of the company)
2. Photocopy of Mayor's Permit, BIR Certificate of Registration
3. Photocopy of Business Latest Income Tax Return
4. Photocopy of Business Financial Statement (Bank Certificates, company accounts, etc.)
5. Photocopy of IBP or PRC License for professionals

#### For Minors:

##### If Student:

1. Photocopy of proof of enrollment (School Certificate or Registration, School ID)
2. Original copy of Certificate of Leave of Absence if travelling during school year (**letter of exemption from studies**)
3. Proof of economic means of parents/legal guardian
4. Copy of passport of parents/legal guardian and affidavit of support and consent

##### If travelling with Spouse and/or children:

1. Marriage Contract certified by PSA (**original and photocopy**)
2. Birth Certificates of children certified by PSA (**original and photocopy**)
3. Notarized affidavit of support of parents and proof of financial means

##### If travelling alone or with only one parent:

1. Notarized written consent of non-travelling parent/legal guardian or proof of sole custody of the travelling parent or legal guardian (**Please note that NO CONSENT is required if father's names DOES NOT appear in the PSA issued Birth Certificate**)
2. If only one parent has the sole custody of the child (**Photocopy of Court Decision awarding custody to that one parent must be submitted**)
3. Copy of Parent's or Legal Guardian's Passport
4. PSA Birth Certificate of the minor issued on (**original and photocopy**)
5. Department of Social Welfare and Development clearance (ONLY if the minor is travelling alone) (original and photocopy)



**For Non-Filipino Applicants who have valid residence status in the Philippines**

1. Photocopy of Alien Certificate Registration (ACR) valid at least 3 months beyond the date of departure from the territory of the Member States.
  
- C. Document to submit specifically for Travelling for the purpose of Tourism  
(PROVIDED BY AGENCY IF TOUR PACKAGE)**
  1. Proof of Accommodation:
    - Confirmation of Hotel Booking / Hotel Voucher
    - Letter of Invitation of accommodation by a host with contact information, proof of nationality certificate as proof of identification/status in the U.K, home utility bills, deeds, and proof of financial means
  2. Detailed day to day planned trip itinerary
  3. Flight Itinerary (Round-trip)
  4. Travel Insurance with Covid-19 Medical Coverage
  5. Proof of Payment
